

This report provides a summary of community development activities undertaken across communities in the North West of Australia, including Karratha, Roebourne and Exmouth, on behalf of the North West Shelf Project, and the Scarborough project, including Pluto Train 2.

Since commencing operations in 1984, the North West Shelf Project has delivered more than 6,000 LNG cargoes, and Scarborough, which is currently in the construction phase, is targeting 2026 for its first LNG cargo. The NWS Project, Pluto LNG and the Scarborough - Pluto Train 2 Project play an important role in our continued contribution to the local communities in the region.

Our current and future operations enable Woodside to continue to contribute to the community by supporting strong local content, economic outcomes, positive social contribution impacts, and sustainable local supply chains. We are proud to maintain a strong local workforce in Karratha and provide employment and training opportunities, assisting our trainees and apprentices to gain the skills needed for future careers in the industry.

In 2022, Woodside and our joint venture partners committed to investing up to A\$65 million over the next five years to support community development in the North West of Australia. The contribution is set to include both new opportunities and the extension of current partnerships in Karratha, Roebourne, Exmouth and Onslow.

The increased funding will be used to help improve local capability and capacity and tackle the issues and opportunities that are important to our host communities.

NORTH WEST SHELF PROJECT

For almost four decades, the NWS Project has been producing affordable and reliable energy for Western Australian and global customers and investing in the Pilbara community.

As one of Australia's largest producing oil and gas projects, the NWS Project is a major employer in and around Karratha, supporting the development of a local, skilled workforce through training and employment pathways and contracting opportunities. The operations of the NWS Project's Karratha Gas Plant underpin significant and sustained investment in Western Australia.

In 2022, the NWS Project invested more than A\$4 million throughout the City of Karratha, including volunteering, assisting with service worker accommodation, education focused-programs, community events and early childhood development, and through partnerships with Ngarluma and Yindjibarndi Foundation Limited (NYFL).

Our presence in the local community continued to grow in 2022, with the NWS Project's residential workforce totalling around 500 employees, including 88 apprentices and trainees and 60 Indigenous employees. The Project also appointed 23 local City of Karratha residents to jobs throughout the year.

KARRATHA EDUCATION INITIATIVE

In 2022, Karratha Senior High School celebrated 15 years of collaboration and partnership with Woodside and the NWS Project through the Karratha Education Initiative (KEI).

The KEI focuses on providing opportunities for students to engage in programs and activities that strengthen academic achievement, deliver positive educational outcomes, enrich learning experiences, and support their health and wellbeing. It represents one of the most innovative education partnerships in Australia and continues to make a significant contribution to the quality of schooling in Karratha.

The Initiative enables access to a suite of innovative programs, including access to Australian Tertiary Admission Rank (ATAR) revision seminars in Perth and Karratha, the Leeuwin II Ocean Adventure Scholarship program and specialist science, technology, engineering and mathematics (STEM) education.

Initially designed to bridge the gap between the opportunities and resources available to students in Perth and those residing in the Pilbara, the partnership has evolved over more than a decade to support students on their pathway to employment. The KEI also assists in the attraction and retention of quality teachers for the region through the delivery of professional learnings and development, building teacher expertise, experience and capability.

COMMITTED TO LOCAL CONTENT Ngarluma Yindjibarndi Foundation Limited-Tutt Bryant

In 2022, Woodside signed a five-year outline agreement with Ngarluma Yindjibarndi Foundation Limited-Tutt Bryant (NYFL-Tutt Bryant), formerly Garlbagu Tutt Bryant, to supply general rental equipment to its onshore and offshore Australian operations.

NYFL-Tutt Bryant is a joint venture between Ieramugadu-based (Roebourne) Traditional Owner organisation, NYFL and construction machinery and equipment supplier, Tutt Bryant.

The agreement will support the continued growth of NYFL-Tutt Bryant's hire business capability and deliver additional opportunities for Indigenous participation through employment and training within the joint venture's operations. This increase in capability provides skills development pathways and employment opportunities for those in the community while securing the delivery of an important service for the NWS Project.

SKILLS DEVELOPMENT AND TRAINING Warrgamugardi Yirdiyabura Program

Since 1998, the Woodside operated NWS Project has supported the delivery of vocational employment and training opportunities in Roebourne through collaboration with the Ngarluma Yindjibarndi Foundation Limited (NYFL). The NWS Project is a proud partner of the Warrgamugardi Yirdiyabura (WY) Program, a NYFL-led initiative, which creates pathways for people in Roebourne to gain accreditation and employment in an area of their interest and choice.

In 2022, the NWS Project increased its contribution to the WY Program, taking the total amount contributed in 2022 to A\$1 million. The contribution has enabled 63 Indigenous participants to undertake training and education opportunities, an increase of 12 participants from the previous year.

Over 300 participants have taken part in the WY program across more than two decades.
